### \*Newly elected board members

### \*Dogs

- Uncontrolled dogs continue to be a problem around Prospect Plaza. Residents of Prospect Plaza and The Boulders own these dogs.
- Motion made by Cameron Bingham to send a letter to our residents and The Boulders HOA requesting that from this point forward, please control and clean-up after their dogs. A copy of the letter will be sent to the Mountain Village Police Department.
  Dan Savage seconded the motion. All board members vote yes and the motion is passed.

# \*New business introduced by list of complaints/concerns received from Jeffery Fasolo

- Elevator Shaft
  - Motion made by Dan Savage to install an exhaust vent from boiler room into elevator shaft. Cameron Bingham will provide a Carbon Monoxide detector. Dan Savage will talk to Nate of Pallante Plumbing & Heating about this. Bob Gleason seconded the motion. All board members vote yes and the motion is passed.
- East Side of Building
  - o It is cleaner than it was. Small steps have been taken since the last meeting at which this was discussed.
  - Letter needs to be sent to Telluride Roofing regarding their materials, etc., which have been left outside for quite some time.
- Idling
  - o Residents need to contact the police regarding this issue.
- North Side of Building
  - Motion made by Cameron to send a warning letter out to all owners via certified mail. The letter will inform everyone that all equipment and storage containers will be towed if not moved off the property ten days after the date of the letter. Dan Savage seconded this motion. All board members vote yes and the motion is passed.
  - o Long-term parking is not allowed in either of our two parking areas.
- Back Fence
  - o This is not a Prospect Plaza issue.
- Missing Tree
  - O Cameron Bingham will contact Paul Sherry to let him know that the tree needs to be replaced in the spring.

- West Side Road Parking
  - o Parking in this area is absolutely not allowed. This issue will be addressed in the letter that is sent to all owners.
- Tapestry
  - O Chip Wilson has left a tapestry sitting in the hallway that needs to be moved. A letter will be sent directing him to move it ASAP.
- A letter needs to be sent to Jeffery explaining our response to the issues on his list.
